SUBJECT: Notice of Transmittal: Request for Feedback on Statewide Senior Legal Helpline Proposal

The Administration on Aging (AOA) recently released a program announcement and grant application for Legal Assistance Grants. AOA plans to fund six to eight statewide grants to states proposing a cost-effective way to increase the number of seniors who receive quality legal assistance, particularly the underserved.

The Department of Elder Affairs is pleased to announce that Bay Area Legal Services (BALS) is applying for this statewide grant in order to establish a Senior Legal Helpline in Florida. BALS is the Title IIIB provider for PSA six and currently operates a regional legal services hotline serving a five county area. Their experience in running a local hotline and their longstanding commitment to serving seniors ensures their proposal to establish a statewide legal helpline will be competitive.

However, a key component of the grant application is evidence of statewide planning and participation in the Helpline. As an important part of the aging network in the state, your consideration of the proposal concept from BALS (see attached) and provision of feedback is crucial to meeting grant requirements. Additionally, your ongoing commitment to the project through partnership with the Helpline will ensure the most vulnerable will be reached and delivery of legal services to seniors will be enhanced. Please review the attached proposal and provide your feedback through responding to the following questions:

1. Do you support the project as described in the proposal?
2. If you support the project, would you participate in developing the referral matrix described in the proposal?
3. If you support the project and your agency currently does not have sufficient resources to provide legal services to all applicants in your service region, would you refer legal clients to the Helpline?
4. If you support the project, would you help disseminate materials about the Helpline in your geographic area, including making special efforts to target isolated, rural, limited English-speaking and other hard to reach populations?
